

PRIVACY POLICY

The Washington Square Hotel values you as our guest and recognizes the importance of safeguarding your privacy by adopting high standards ensuring protection of personal information. This information is provided by you through use of our website when you make reservations or when you contact us directly by email, phone, in writing, or via social media, as well as through third party websites and applications used to make reservations.

We collect information to help identify and contact you such as:

- Full name
- Address
- Phone number
- Email
- Payment information
- Identification document such as passport or driver's license
- Any other information provided to and by the third party

Please note that there are circumstances in which we may not be required to provide you with the information contained in this Privacy Policy due to legal or national security concerns.

• We are obligated to keep your information confidential in accordance with the regulations set by the European Union or the European Union member state law.

Voluntary Surveys

We periodically send our guests survey requests and encourage you to complete them. These surveys help us improve our customer service as well as inform our guests about special offers and promotions.

Your participation in these surveys is voluntary and you can opt out of receiving promotional emails at any time.

We agree to:

Washington Square Hotel Accounts

When you make a reservation via our website you are required to create an account. Washington Square Hotel member accounts are secured by member-created passwords. Our

We use reasonable measures to protect member information stored within our database, and restrict access to member information to employees who need access to perform their job functions, such as our reservation department or front desk. However under such circumstances we inform the proper channel of authority to deal with such matters.

Sharing and Disclosure of Information Collected

- To enforce the Washington Square Hotel Terms of Service Agreement or to protect our rights
- To protect the safety of members of the public and users of the service
